ABOUT US

Pastalaya on the Bayou is a cooking competition that provides Houma and surrounding areas a fun Saturday to come out and eat all the Pastalaya you want for an \$8.00 fee. The event will also include live music, craft vendors, silent auction, 50/50 raffle and more. The event is managed by Childrens Water Safety Awareness, a 501(c)(3) non-profit organization based in Houma, La. that promotes water safety to all in our area and provides support to those who have lost a loved one to a drowning incident. Childrens Water Safety Awareness directly represents four families who have lost children to drowning incident, all under the age of three. Proceeds from the event will give free swimming lessons to children, CPR lessons to adults, as well as hopefully starting a life jacket trade up program that should be up and running soon. The event is scheduled from 8:30 am to 6:30 pm on Saturday, October 28, 2017 at the Houma Courthouse.

BOOTH SPACE

1. Booths will be reserved and accepted on a first-come, first-serve basis by Saturday, October 21. Vendors are asked to make a donation to the event.
2. Operational hours for craft vendors will be 9:00 a.m. to 6:00 p.m. Saturday, October 28.
3. All craft vendors will be strategically placed inside the Courthouse Square or on Goode Street. Vendors must supply their own tents, tables, chairs and any other supplies needed for the sale of their products. Vendors must also provide sufficient staffing in booth(s).

Event management will not provide cash or change during the event.

REGISTRATION, SET-UP & PARKING PROCEDURES

Registration will begin upon load-in on Saturday October 28th at 8:00 a.m.

Vendors will be required to visit the registration booth prior to setting up to discuss booth area. Drop-off for loading and un-loading will be allowed during setup/tear-down time only. Parking will not be allowed inside event grounds.
